General Notice

McGill – Ruth Sewer & Water G.I.D (Owner) is requesting bids for the construction of the following project:

McGill Sewer Treatment Improvements – Phase 2 Project Number – WP-2025-337

Bids for the construction of the project will be received at the **McGill – Ruth Sewer & Water GID office** located at **29 Fourth Street, McGill, Nevada**, until **October 29, 2025**, at **2 pm** local time. At that time the bids received will be publicly opened and read.

The project includes the following work:

Mobilization and demobilization; new electrical; new aeration blower, piping, and diffusers in pond 2; removal and disposal of accumulated sludge in pond 1; removal of old aeration equipment, posts, baffle curtain, liner in pond 1; new grading, geotextile under liner and plastic pond liner in pond 1; new baffle curtain in pond 1; new aeration blower, piping, and diffusers in pond 1; new plug valves and piping for four rapid infiltration basins.

Bids are requested for the following contract: **McGill Sewer Treatment Improvements – Phase 2**

Owner anticipates that the projects total bid price will be approximately **\$2,400,000**. The project has an expected duration of **150** days.
